same areas be eligible for assistance under practice under this legislation to have resithe ARDA program?

Mr. Sauvé: Were they designated under the ADA program or the ARDA program? I believe there is only one designated area under the ARDA program so far, and that is the Interlake region.

On clause 7-Establishment of advisory board.

Mr. Dinsdale: I have a brief question on clause 7 with respect to the advisory board. The hon. member for Qu'Appelle raised this point during his excellent presentation at the second reading stage. Can the minister inform the house if there is any liaison between the advisory board and the resource ministers council through its permanent secretariat? I think it is most important, if we are going to have co-ordination of any comprehensive plans for resource development, that we not only have intergovernmental co-operation, that is co-operation between governments, also intragovernmental but co-operation. There are so many various departments at the federal level in the field of resource development, and the function of the resource ministers council was to achieve some overall co-ordination. Is there consultation?

Mr. Sauvé: As the hon. member knows, the secretariat has no administrative authority. What happens is that the secretariat is informed of the projects and programs that are carried out under ARDA. The ARDA program is reviewed annually by the committee of ministers. We submit to them everything we do. They have an annual report on what we are doing, and it is always on the agenda of the resource ministers conference. In this way some co-ordination can be maintained.

Mr. Schreyer: I believe that under clause 7 the minister was going to make some response to my question as to whether or not it was the practice that the people actually affected in these designated areas be given representation on these boards. If I might just clarify, Mr. Chairman, it is my understanding that in the special rural development areas there is an area development board to be established. I understand that the area development board will be comprised primarily of individuals from the government. I ask the order, I believe that this is the first time this

dents of the area itself as representatives on these boards?

Mr. Sauvé: Mr. Chairman, in answer to that question I will refer to paragraph 33 of the federal-provincial rural development agreement, part VI. I quote:

A comprehensive rural development program involves the following:

2. The involvement of local people through the establishment of rural development committees or similar bodies.

It is a condition that in the implementation of this Bill No. C-151, there should be committees at the local level.

Mr. Stewart: Before the clause carries, I should like to ask the minister if the Atlantic Development Board will be represented on the advisory board?

Mr. Sauvé: Yes, Mr. Chairman.

Clause agreed to.

Clauses 8 to 10 inclusive agreed to.

Clause 1 agreed to.

Title agreed to.
