concrete way with the provinces are obviously different, may I ask the Minister of Finance first, and the Minister of National Health and Welfare second, whether they would undertake to make a statement to the house as to the discussions that have taken place with their counterparts in the provinces in connection with this matter?

Mr. Benson: Mr. Speaker, I think that the proposal I made to the provinces was basically the same as that made in 1966 by the minister of finance.

Mr. Lewis: But we ought to hear it.

Mr. Benson: I did not materially change the proposal. I referred the Leader of the Opposition to some pages in *Hansard* and I would also refer this hon. member to them. They outline the programs involved. In addition to this, I would refer him to the Medical Care Act and what is contained therein.

Mr. G. W. Baldwin (Peace River): Mr. Speaker, I should like to ask the Minister of Finance a supplementary question. In order that the government and the provinces may at all times have careful and precise knowledge of the cost of these programs, would the minister lend them his computers?

QUEBEC—LOANS FOR HYDROELECTRIC DEVELOPMENT

Mr. André Fortin (Lotbinière): Mr. Speaker, I wish to direct a question to the Minister of Finance.

Since the Canadian government has made a \$32 million loan to the Newfoundland Hydro-Electric Commission at $5\frac{1}{4}$ and $5\frac{7}{8}$ per cent interest per year, as recorded at page 2201 of Hansard, and since Hydro Quebec has just floated a \$50 million bond issue, does the Canadian government intend to grant the same facilities to Hydro Quebec at the same rate as Newfoundland?

Benson (Minister of Finance): Mr. Speaker, I believe the loans to Newfoundland—though I should like to check this first—are made under the Atlantic Provinces Power Development Act, which is a specific act passed by parliament setting out the conditions under which loans can be made to the

Atlantic provinces for this particular kind of development. It is, of course, part of the development program to encourage expansion in the Atlantic provinces and to overcome regional disparities.
