stone unturned to create greater public disclosure in Canada.

Mr. Lewis: A supplementary question, Mr. Speaker. I was certain the minister would agree that the report of the joint committee on consumer prices of the House of Commons and Senate was a good report. I suspect he wrote part of it.

Mr. Knowles (Winnipeg North Centre): After all, he was the chairman.

Mr. Lewis: Yes, he was the chairman. I would like to ask the minister whether his amendments in any way affect such problems as the policies to be pursued by Canadian subsidiaries of United States multinational firms in terms of sending assets or money back to their parent companies, or the policies that may be pursued with respect to foreign trade and the like, or are the amendments limited to disclosure only?

Mr. Basford: Mr. Speaker, some of the matters the hon, member raises could not properly be covered in a companies act or a corporations act. The amendments I will be drawing and introducing will be concerned solely with the legal framework within which companies in Canada operate, and more But I have cause to doubt his diagnosis of the specifically those that receive letters patent country's temper on this matter. under the Canada Corporations Act.

Mr. Speaker: Order, please. I am not sure that the right hon. gentleman's question is personal but it is certainly argumentative. However, in view of the interest in the matter the Prime Minister might want to reply.

Right Hon. P.-E. Trudeau (Prime Minister): If you wish, Mr. Speaker. If the right hon. gentleman is right in saying that it will split this country right down the middle, I think the course of the government would be not to exchange representation with the Vatican.
