contributions "interest", what is the annual rate of interest required to pay the level of benefits currently provided for under the applicable regulations and what assumptions as to levels of final earnings are made to produce this rate?

Hon. E. J. Benson (Minister of Finance): If the required credits to the Superannuation Account in addition to the contributions of public service employees and the statutory matching contribution by the Government were regarded as interest, the annual rate of interest in 1968-69 required would be approximately 8 percent.

If the statutory matching contribution by the Government were also regarded as "interest" the annual rate in 1968-69 would be approximately $10 \frac{1}{2}$ percent.

The assumptions as to levels of final earnings are set out in Appendices 1 and 2 of the Report on Actuarial Examination of the Superannuation Account in the Consolidated Revenue Fund as at December 31, 1962.
