#### PROPOSED CUTBACK IN NATURAL GAS SUPPLY BY WEST COAST TRANSMISSION TO BRITISH COLUMBIA THIS WINTER—FILLING OF BOARD VACANCIES

**Hon. Robert L. Stanfield (Leader of the Opposition):** Mr. Speaker, I have a question for the Minister of Energy, Mines and Resources who I know is very fleet of foot. It concerns a report that West Coast Transmission will be cutting back on the supply of gas to British Columbia customers by 10 per cent on peak demand this winter as a result of some difficulty with one of the suppliers to West Coast Transmission. Has the minister been in touch with the National Energy Board and is he satisfied that this cutback is necessary or whether the cutback could not be made in the gas exported by West Coast Transmission in order to give British Columbia customers priority?

### Oral Questions

**Hon. Donald S. Macdonald (Minister of Energy, Mines and Resources):** Mr. Speaker, I saw the president of that company yesterday afternoon and he informed me of the facts referred to in the news report this morning. I have indeed been in touch with the board along the lines suggested by the Leader of the Opposition and I shall be seeking the board's advice on handling this problem. It is related to a structural fault in one of the supplying fields.

**Mr. Stanfield:** Despite the very substantial reserves of natural gas in western Canada, is the supply system as authorized and approved by the National Energy Board so precarious that some difficulty developing with one supplier of gas creates this threatened shortage for British Columbia?

**Mr. Macdonald (Rosedale):** Mr. Speaker, I would be glad to canvass that question with the board. I would remind the hon. gentleman that this difficulty relates to the West Coast system as opposed to the Trans-Canada system which is hooked into very much larger reserves, but I think it is a valid question.

**Mr. Stanfield:** Since the minister has referred the matter to the National Energy Board, has he any explanation why the board now consists of five members when the statute provides that the government shall appoint seven, and why the board has been without a chairman for more than two months in a situation of great difficulty and importance in the energy field?

**Mr. Macdonald (Rosedale):** Mr. Speaker, I hope to make some announcement in this regard in the relatively near future.

#### ASSURANCE TO BRITISH COLUMBIA OF ADEQUATE SUPPLY OF NATURAL GAS THIS WINTER

**Mr. T. C. Douglas (Nanaimo-Cowichan-The Islands):** Mr. Speaker, I have a supplementary question. In view of the request of the British Columbia government for some assurance from the minister that they will have an adequate supply of natural gas this winter and that British Columbia customers will be given priority over exports, has the minister been able to give that assurance to the British Columbia government?

**Hon. Donald S. Macdonald (Minister of Energy, Mines and Resources):** Not yet, Mr. Speaker. As I have indicated to the Leader of the Opposition, upon my return this morning I immediately put the question to the National Energy Board. I received, of course, a telegram to the same effect from the Attorney General of British Columbia. I hope to be able to respond both to the House and to that gentleman at an early date.

**Mr. Douglas:** In view of the fact that the National Energy Board gave export licences to West Coast Transmission, would the minister undertake to find out why, before giving such export licences, the National Energy Board did not assure itself that West Coast Transmission had adequate reserves to meet a contingency such as that which has arisen?
