

rail system and hamper future attempts to promote public transportation systems and fuel economy.

I believe it is extremely important for Parliament to debate this impending termination of rail service before the order in council implementing the cuts takes effect on November 15, 1981. For dozens of communities and tens of thousands of individual Canadians, this is an emergency situation on which Parliament is entitled to be heard. Madam Speaker, if you find this situation does justify the invocation of Standing Order 26, I will be prepared to move the appropriate motion.

Madam Speaker: Again there is little doubt that the matter raised by the hon. member is of national interest and of great concern to Canadians generally. However, in determining whether the question raised may require an emergency debate, I have to measure this application against a number of criteria.

The hon. member realizes it would be difficult to apply the provisions of Standing Order 26 in the case of decisions taken by outside entities while carrying out their normal functions, namely, the Canadian Transport Commission. It is obvious that modifications to rail service in this country are made on a continuing basis. These matters have been constantly rejected by the Chair as not constituting a proper subject of debate under the provisions of this Standing Order. As a former minister of transport, I am sure the hon. member is aware of other avenues in which he can raise his concerns. Of course, it is with reluctance that I cannot accept his application.
