## **BUSINESS OF THE HOUSE**

I do not believe we ever discussed it on the basis referred to by the minister. I am making this point while the parliamentary secretary is here so that we will not have any misunderstanding of our intentions on this matter.

**Mr. Collenette:** Yes, Madam Speaker, I concur in the sentiments expressed by the hon. member for Nepean-Carleton. In the discussions which we have had, we spoke about a very short debate on Bill S-2. I do not believe there was any specific agreement to limiting the speeches to one speaker per party, but we hope to get the bill through very quickly tomorrow.
