DIRECT JOB-CREATION PROGRAM—DESIGNATION OF ELIGIBLE CONSTITUENCIES

Hon. Flora MacDonald (Kingston and the Islands): Mr. Speaker, in the absence of the Minister of Employment and Immigration, the Minister of Finance and the Prime Minister, I will put my question to the President of the Treasury Board.

Some hon. Members: Oh, oh!

Mr. Rémi Bujold (Parliamentary Secretary to Minister of Employment and Immigration): Mr. Speaker, since the hon. member's question referred to the 33 constituencies that were designated, the hon. member ought to know that these constituencies were designated on the basis of a 12 per cent labour surplus throughout the country. The constituencies are located in the Maritimes, and obviously, the hon. member is not talking about her colleague from St. John's West, whose
