# FULL INDEXATION OF FAMILY ALLOWANCES AND CHILD TAX CREDIT

**Mr. Jean-Claude Malépart** (Montreal-Sainte-Marie): Mr. Speaker, I have here several petitions, but I am sure you would not like me to table all of them today, so that all my friends may hear about them.

Mr. Speaker, my first petitions are from my own constituency. To spare you, I am going to table most of those which strongly object to the Government's decision to cut the increase in family allowances and which ask the Prime Minister not to reduce his deficit on the backs of Canadian children.
