# IMMIGRATION-REFUGEE CLAIMANTS

Mr. Dan Heap (Trinity-Spadina): Mr. Speaker, it is my honour and duty and my pleasure to present a petition duly certified by the Clerk from over 200 people in Trinity-Spadina and other parts of Toronto who are concerned about what may happen to over 120,000 people now in Canada who are in the refugee backlog from previous years because some of them do not have work permits with which to maintain themselves or they want to work. They will all be examined in a way that may be unfair or inadequate on humanitarian considerations, the grounds of humanitarian or compassionate consideration to include the presence in Canada of relatives and the successful establishment of refugee claimants in Canada. They want special consideration for those refugee claimants from war zones, under oppressive Governments and affected by natural disasters.
