#### HEALTH CARE

#### SOFTWOOD LUMBER

Mr. Robert E. Skelly (Comox—Alberni): Mr. Speaker, I have the pleasure of presenting a petition from several hundred constituents drawing the House's attention to the fact that the United States has unfairly imposed a duty on our softwood lumber exports to that country and has engaged in numerous other trade practices which amount to harassment to Canadian producers.

They also note that the free trade agreement between Canada and the United States has resulted in lost jobs and the devastation of the Canadian economy while not providing the promised benefits.

Therefore they call upon Parliament to request that the Prime Minister and the minister responsible for international trade take any action necessary to defend the interests of the Canadian softwood lumber industry against unfair duties and also to request that Parliament act immediately to effect the cancellation of the Canada–U.S. Free Trade Agreement.

#### VIOLENCE AGAINST WOMEN

Mr. Dennis Mills (Broadview—Greenwood): Mr. Speaker, pursuant to Standing Order 36, I have the privilege to present to Parliament petitions signed by hundreds of constituents. They humbly pray and call upon Parliament to accept legislation designed to eliminate violence against women and children.

They want to encourage and support women to report incidents of assault or abuse, provide assistance and support for women reporting assault or abuse, and provide relief and support to women as mothers to protect their children.

We need legislation to emphasize the need for abuser rehabilitation and we must concentrate a special effort on training of police, lawyers, court workers and judges to become knowledgeable about women and child abuse and to focus public attention on this very important and long ignored problem.
