Hon. Mr. Isnor: Could the honourable Leader of the Government tell us whether there is any provision in the agreement which would provide energy to private companies, other than the two mentioned, such as the grid line in other parts of Canada?

Hon. Mr. Connolly (Ottawa West): At the moment I cannot answer that question. If after the summary and report are made available to honourable senators there are further questions to which I can provide answers, I would be happy to do so.
