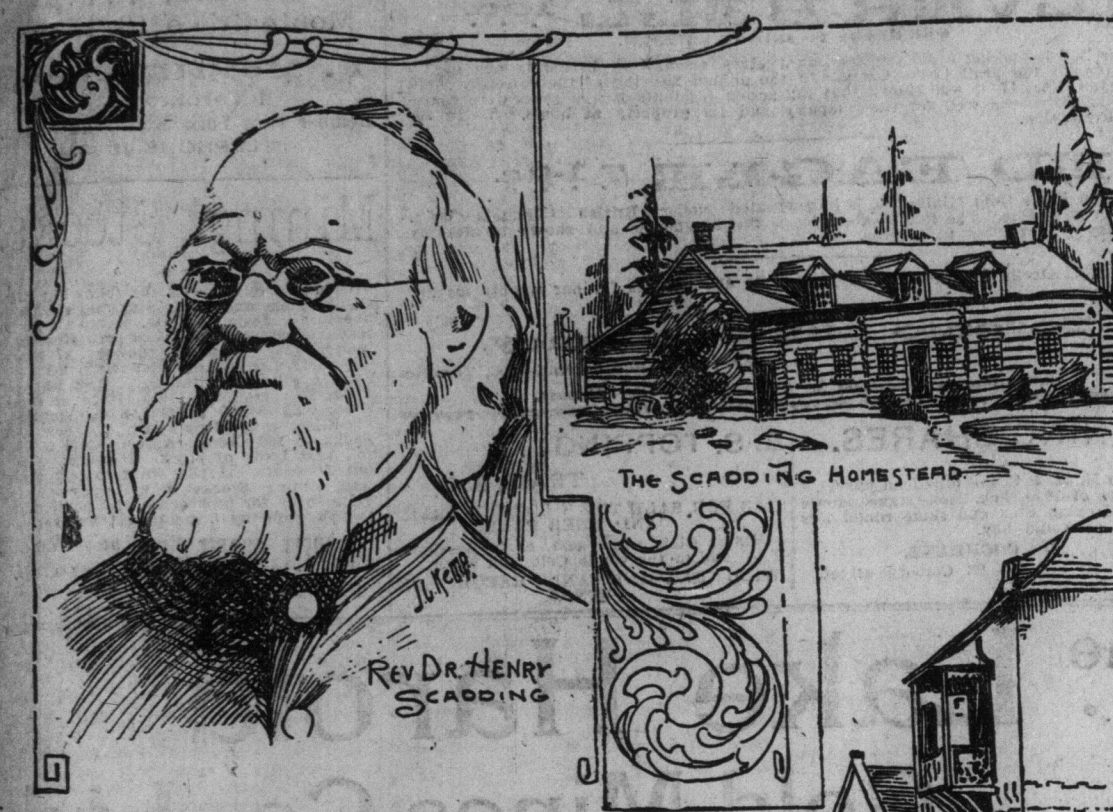


ONE OF TORONTO'S OLDEST PIONEERS.
