Uncertainties of the Canadian Tariff in Regard to Preferences Have Acted as a Check.

Montreal, Sept. 21.—The Star publishes the following special cable from London:

In view of the uncertainties in the minds of the English shippers respecting the Canadian tariff, the London Chamber of Commerce is issuing to-morrow an explanatory circular.

Mr. Kenric Murray, the secretary of the Chamber, tells me that the expectations of the traders have undoubtedly been disappointed by the extension to practically all countries, except the United States, of the preference previously supposed to be an exclusive British preference. This has tended to check the expected diversion into purely British channels of trade now done through Britain with France, Germany, etc.

Another startling incident is the sense of exact official information as to the intentions of Canada after August next. Will the preference then be exclusively British? Still, much is hoped from the tariff. At least half a dozen good houses have sent representatives to Canada, with a view of establishing branches.

The visit of the British Medical Association is stimulating the surgical instrument trade with England. The tariff, moreover, is encouraging those who found the old tariff and the absence of an insolvency law insuperable obstacles to agent push Canadian trade. It is hardly expected, however, that the agreement will show a material effect on the returns till November.
