Sir,—In accordance with your instructions we have examined the Books and Accounts recording the Financial transactions of the Government of the Province of New Brunswick for the fiscal year ending October 31, 1919, and certify that, in our opinion, the Balance Sheet at that date attached herein exhibits a true and correct view of the financial position of the Province as at October 31, 1919, according to the best of our information and the explanations given to us, and as shown by the Books of the Province.

During the year ending October 31, 1919, an amount of \$244,807.45, representing interest charges on the Bonds and other indebtedness of the St. John & Quebec Railway, less the Province's proportion of the Railway Earnings, has been capitalized. The additions to the Capital Accounts of Roads and Bridges represent Expenditures classified as Permanent by the Provincial Engineers.

Common Council Met In Committee

Delegation of Steamship Representatives Objected to the Discharging of Ballast from Ships Into Carts—Council Decided to Do Away With That Section.

The common council met in committee yesterday morning and met representatives of the steamship interests at this port.

The delegation consisted of J. T. Knight, representing J. T. Knight & Co.; J. P. Doherty, of the Canadian Government Merchant Marine; R. W. Wigmore, representing the Canada S.S. Lines; D. W. Ledingham, of Furness Withy & Co.; H. C. Schindler, of the Robert Reford Co., and J. Turcot, representing McLean, Kennedy & Co.

The delegation objected to the discharging of ballast from ships into carts and filling up the Corbett Mill pond. It was shown to the commissioners that the scheme was impracticable as there was not sufficient carts available and the process would tend to hold up steamers and cause delay in discharging ballast.

After the delegation withdrew on motion of Commissioner Bullock, the sections regarding the definition of vessels, leaving out the section referring to the dumping of ballast and the filling of the Mill Pond, was carried.

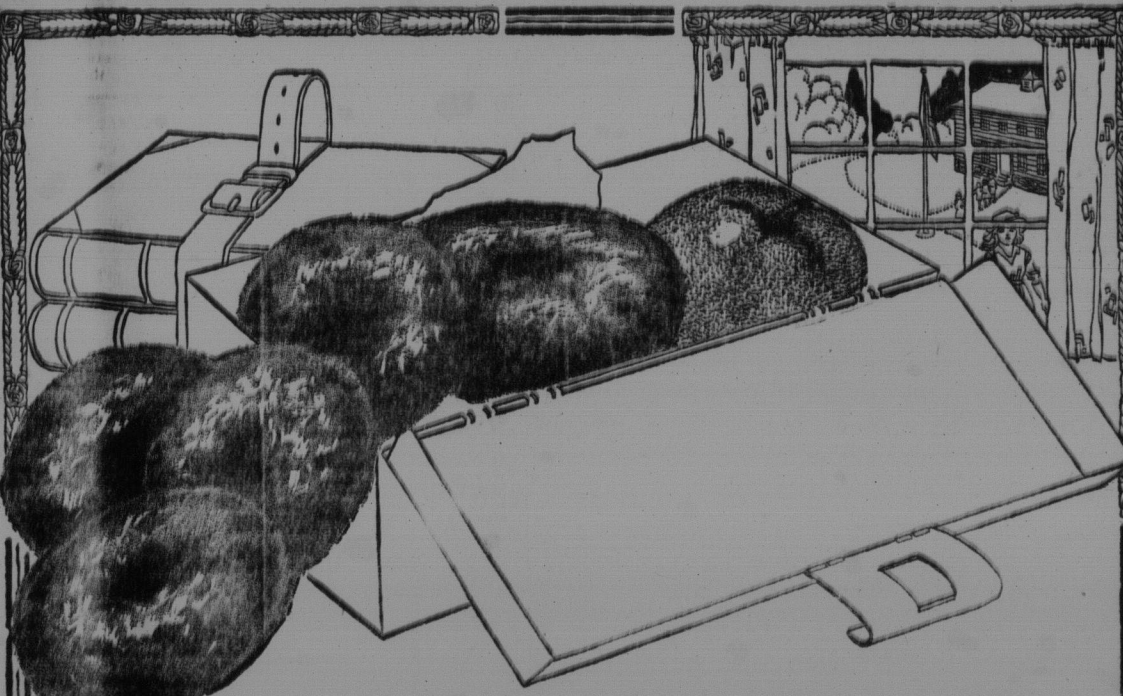
