Arrival of the Niagara.

AUSTRIA AND PRUSSIA JOINED THE ALLIED POWERS.

The Steamer Niagara arrived at Halifax on the 6th inst., at 1 o'clock, P. M. The Pacific arrived out on the 10th.

On the 24th the Arctic repaired engines, in perfect order, injuries confined to planking, of which 70 feet torn off, wanted six new foot books, will sail at 11 forenoon tomorrow, (28th).

Sarah Sands sailed night of 25th for Quebec.

Overland mail at Trieste reports the American Squadron had established friendly relations with Japan. Three Japanese ports are to be opened within one year from date. This news is dated Hong Kong, April 12th.

The war negotiations resumed. Negotiations for renewing the engagements previously contracted for by the Four Powers at Vienna, and to bring to separate treaties trade between France and England and between Austria and Prussia into one quadruple agreement to secure peace, is now completed, and on the evening of Tuesday 22d, Protocols were signed at Vienna by which these separate treaties are annexed to the former engagements of the Four Powers.

This Morning publishes text of the treaty of alliance between France and England and Turkey, signed at Constantinople, March 12th. Ratifications exchanged May 8th, this object being to guarantee the integrity and independence of the Ottoman Empire.

The London Globe publishes that the Austria-Prussia Treaty was related from Vienna. That on the 24th, Austria and Prussia sent joint summons to Russia to withdraw from Turkish Territory, thus adopting policy of Western Powers.

DANGER.—Not much news as to movements of armies. Paskiewich's plans are said to be to besiege Rastuchuk and Silistria as at present, with 40,000 men. Silistria is kept in check by Lobanoff's corps, and the main body will separate on the Balkans.

VIEW.—Lloyd's 20th says, Omar Pacha has taken up his position before Schumla, and will meet the Russians there. It is asserted that he has written to Constantinople, stating that he may be compelled to sacrifice Silistria, if allies are not in force at Balkan's by end of May, at latest. Meantime siege of Silistria is pushed on with vigour.

On 16th, terms of capitulation were offered to the commandant, but were rejected, and on 17th bombardment recommenced.—Gen. Schilders commands Russian Engineers, has 70 guns in position, but we have no advices whether he operates by regular approaches, or whether the firing is still carried on from opposite side of the river.—City and defences have already suffered severely, and if above statement of Omar Pacha's be true cannot long hold out.

On 18th Paskiewich had his headquarters at Kalarash. A Constantinople despatch, May 15th, says that Russians had cut off communication between Silistria and Varna, and the coast also between Varna and Schumla. Another letter states that on 20th Silistria was still in the hands of Turks. The 1st division of allies was in motion to join Omar Pacha, and act as reserve.

From BELGRADE, May 18, Despatch says—every thing here perfectly quiet. Not a movement for some days past from seat of war. Intrenchments for defence of Dardanelles nearly completed, and line to protect Constantinople will be commenced without delay.

BLACK SEA.—Advices to May 11, mention nothing of any Attack on Sebastopol. Report that the whole coast of Crimea was blockaded by 27 ships.

Main of allied fleets was cruising near Sebastopol.

Letters report that British steamer Tiger went ashore and was taken by Russians, that 7 British frigates went to Odessa to demand restitution, which Russians contemptuously refused and City was again bombarded for 6 hours.—Date of bombardment not stated, and some doubt is thrown on truth of report.

Admiral Hamelin has written for troops for land service in Crimea. They will be sent.

BATTIE, 16th.—No attack had been made on Reveland, or any other Russian Port. Russian fleet had been seen in Hauge Bay.—British fleet were 50 miles distant, apparently reconnoitering enemy's movements.

Terms of ultimatum of Western Powers to Greece are observant of strict neutrality; also prosecution of Greek subjects who had joined insurgent Greek officers in insurrection is to be immediately recalled and degraded from their rank in Greek service. A definite reply is demanded before a certain date. If not Greek coast will be blockaded.

Report of the taking of Russian ports of Castellan with 1500 prisoners were current, but doubtful.

GENTLEMEN,

The Export Duty on Hackmatac, I believe to be a direct tax upon the tree, and is paid by the poor man who prepares it for the market.

Believing that New Brunswick, owes to every child within its limits, the opportunity of getting an education, I would advocate a school system, by which the children of the Poor, as well as the rich, could enjoy that natural right.

As a tried friend of Temperance, I would employ every honest means to advance that cause.

I would advocate a system of Government, by which the people could manage their local affairs, and thereby save much time and money, now wasted in the Provincial Assembly, and would further prevent the Representatives, from conferring favours upon their particular friends, regardless of their qualifications to discharge the duties assigned them.

I would give to the Fisheries of New Brunswick all the encouragement, due to that important branch of our industry.

I would advocate a registration of Voters and Vote by Ballot.

Should I be chosen one of your Representatives, I will serve you to the best of my ability; and when my actions fail to please a majority of my constituents, I will resign. My conduct shall be influenced by principles of justice, which I trust will prompt me to legislate fairly for all, without regard to the country of their birth, or their religious creed.
