THE Boston Commercial Bulletin says: Our trade in oranges is becoming more of a business every year. The importations this winter have been large, and of great variety. Some of the shipments of foreign fruit came by way of Liverpool, but the principle importations of oranges and lemons are direct from Paleimo, Messina and Valencia. A recent invoice of oranges was from Jaffa, Palestine, the fruit being of peculiar appearance, and somewhat eggshaped. One Boston house is expecting an invoice of California oranges, coming overland, which it is thought will sell for about \$3.50 per box, if they arrive in good condition.
