**PACIFIC CONFERENCE**

QUESTION AS TO CONSIDERATION OF A PACIFIC  
PACT

On the orders of the day:

**Mr. J. G. Diefenbaker (Lake Centre):** Mr. Speaker, I should like to direct a question to the Secretary of State for External Affairs, having to do with the departure of the Minister of Fisheries (Mr. Mayhew) to attend the Pacific conference. I know the house will wish him well on his trip to represent Canada at that meeting. Within the last two days the press has stated that the governments of Australia and New Zealand intend to press at that conference for a Pacific pact, and will ask for the support of North America. What stand will the minister take at that conference on behalf of the people of Canada in reference to including Canada in the Pacific pact?

**Hon. L. B. Pearson (Secretary of State for External Affairs):** The conference to which my hon. friend has referred will open in Sydney on May 15, and, as has been stated, the Minister of Fisheries will represent the government at that conference. It is a meeting of the commonwealth consultative committee recommended by the commonwealth conference held at Colombo last January. This conference will discuss recommendations for economic and technical help through the commonwealth organization to the countries of southeast Asia. It is not expected by the Canadian government that political questions of the kind indicated by my hon. friend will be discussed.

**Mr. Diefenbaker:** Indicated by the Prime Minister of New Zealand.

**Mr. Pearson:** The matter may be brought up by some member of the conference, and if so, the Canadian delegate will report that fact back to his government. As we did not expect that this subject would be a matter of discussion, no decision has been taken by the government as to what the Canadian delegate would do if it is brought up.

**SUPPLY**
