Last evening the Minister of Trade and Commerce took the opportunity as has been usual with this government, to announce outside the house the awarding of this contract. I say to you, sir, in my opinion it is obvious that there has been interference by the Prime Minister beneficial to his own riding and detrimental to the rest of Canada.

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, that statement is entirely uncalled for and untrue.
