**Hon. Judy V. LaMarsh (Secretary of State):** Mr. Speaker, I am informed by the C.B.C. as follows: 1. Sets were assigned to members of the C.B.C. board of directors, to the Canadian representative of the British Broadcasting Corporation, to the office of the Secretary of State, to the Prime Minister's residence and to Government House. It has been C.B.C. practice for some years to make sets available as a courtesy to these offices and individuals.

8. What was the total establishment for community development officers and assistants approved by the cabinet up to the fiscal year 1966-1967?

9. How many of these positions are now filled, how many vacancies exist and how many of the personnel have been converted to non-community development work?

\*DELAYS IN APPLICATIONS FOR TRADE MARKS

Question No. 2,676—**Mr. Woolliams:**

1. Is the trade marks branch of the Department of the Registrar General, owing to a shortage of staff, now several months behind in the examination of applications in reference to trade marks?

2. Would the minister kindly investigate the situation, and what promise does he hold for applications being delayed presently or to be delayed in the future?

**Hon. John N. Turner (Member of the Administration):** 1. The normal processing time for the examination of trade mark applications based on proposed use of trade marks has not changed, but a slight delay has been encountered in the processing time of applications based on use of trade marks, due to a higher turnover recently in the examining staff. The production, of course, of the newly employed examiners, because of their lack of experience, cannot be as high as that of former employees.

2. Arrangements, however, have been made with a view to remedying the situation.
