On Monday we propose to call the National Library bill for second reading and then the second reading of the Co-operative Credit Associations bill and the hazardous products bill.

On Tuesday we would return to the omnibus Criminal Code bill. Having already had five days of debate I would hope we would continue that stage to completion. Afterwards we would have the report stage of the drug prices bill.

On Wednesday we propose to begin the second reading debate on the government reorganization bill and continue with that measure at advanced stages on Thursday next.
