**Mr. Woolliams:** On a point of order, Mr. Speaker, and I can make it very briefly. I suggest that the Solicitor General has never read the white paper and he should take the time to study it.

**Mr. Speaker:** I am sure that on reflection the hon. member for Calgary North will recognize that this is not a point of order.
