#### SUGGESTED ISSUANCE OF WARNING TO STUDENTS CONCERNING DRUG OFFENCES IN FOREIGN COUNTRIES— REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION

Beattie (Hamilton Mountain): Mr. Speaker, I rise under the provisions of Standing Order 43 on a matter of urgent and pressing necessity, namely, the incarceration for the past month of four Canadian students in an Iranian jail, as well as the large numbers of requests received by Canadian Embassies around the world for help on drug charges. That this House instruct the hon. Secretary of State for External Affairs (Mr. Sharp) to issue a directive to all high schools, colleges and universities in Canada outlining the dangers and possible penalties that tourists face when arrested on drug charges in a foreign country.

#### POSSIBLE INVESTIGATION OF LAY-OFFS AT GENERAL INSTRUMENTS PLANT, SYDNEY—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION

Mr. Robert Muir (Cape Breton-The Sydneys): Mr. Speaker, I rise at this time under the terms of Standing Order 43 on a matter of urgent and pressing necessity, namely the drastic lay-off of employees at the General Instruments Corporation plant at Sydney, wherein the work force has been reduced from approximately 1,000 employees to the vicinity of 400 employees in the past few weeks.

In view of the fact that it appears close to impossible to secure from the corporation their intentions as far as their future operations at Sydney are concerned, the fact that certain pieces of equipment have been removed from the plant and the hardship that is being caused as a result of this mass lay-off, I move, seconded by the hon. member for Cape Breton-East Richmond (Mr. MacInnis):

That the Minister of Industry, Trade and Commerce (Mr. Gillespie) and the Minister of Manpower and Immigration (Mr. Andras) immediately cause an investigation to be carried out to lend whatever assistance is possible to assist those employees affected by the lay-offs, ascertain as a result of the investigation what the future holds for this plant and also if those who have been laid off will be rehired. And, the minister's report back to the House.

**Mr. Speaker:** This motion is also proposed to the House under the provisions of Standing Order 43 and requires unanimous consent.
