DETROIT INCINERATOR—POLLUTION CONTROL DEVICES

Mr. Howard McCurdy (Windsor—Walkerville): Mr. Speaker, my question is directed to the Secretary of State for External Affairs. In view of the United States Environmental Protection Agency's incompetent bungling of its responsibilities with respect to the installation of decent pollution control devices on the giant Detroit incinerator, what specific representations has the Department of External Affairs made to the United States Government to do something about this serious threat to the health of the citizens of Windsor?

Right Hon. Joe Clark (Secretary of State for External Affairs): Mr. Speaker, we on this side of the House consider that and other environmental questions to be very serious.

FINANCIAL MANAGEMENT SYSTEM

Mr. Bob Pennock (Etobicoke North): Mr. Speaker, my question is directed to the Minister of Communications. Last week the Auditor General claimed that he could not offer a comment on the CBC's financial situation because of the deplorable state of its books and the loss of \$57 million. Since this is the first time that an Auditor General has been unable to report on the financial statement of a Crown corporation, will the Minister advise the House what initiatives she has taken or intends to take to investigate this apparent incompetency of the CBC management, above and beyond the audit which the CBC management itself has commissioned?

Hon. Flora MacDonald (Minister of Communications): Mr. Speaker, concern about the new financial management system of the CBC has been expressed by the Auditor General, by the Chairman of the CRTC, and indeed by others.
