3. Members admitted to seat (after taking Oath) on production of certificate of Returning Officer only; Resolution that in admitting them to take their seats on production of such writs only the House still recommends a strict adherence to the practice of requiring the usual certificate, 41, 58.
4. Bill to repeal an Act to render members of the Legislative Councils and Assemblies of the Provinces of the Dominion ineligible for sitting or voting in the House of Commons of Canada (Mr. Ouimet); Ordered; Presented, 225.
