The company may enter into traffic arrangements or agree-Arrangements for use of line ments with any other railway company or companies for the and rolling stock of other hiring, leasing, working or using the lines of railway of such other railway company or companies, or any parts thereof, at any time railways. or times, or for any period, or for the leasing or hiring any locomotives, tenders, or moveable property, and generally to make any 10 agreement or agreements with any such other company touching the use by one or the other, or by both companies, of the railway or moveable property of either or both, or any part thereof, or touching any services to be rendered by the one company to the other, and the compensation therefor; and any such agreement 15 shall be valid and binding, and shall be enforced by courts of law according to the terms and tenor thereof. 5. No liability or expenditure shall be incurred or powers Consent of shareholders exercised under the four preceding sections unless the consent of to beobtained. two-thirds of the shareholders shall have been obtained at any 20 half-yearly general meeting in terms of the seventh section of the Great Western Railway Act, 1870, or at a special general meeting, if deemed expedient to be called for the purpose, Recital. 6. Whereas the share and stock capital of the Great Western Railway Company is twenty-eight million eight hundred thousand dollars, and the said company have power to borrow upon their 45 terminable bonds a sum equal to one-half the said capital, or fourteen million four hundred thousand dollars, and have already exercised such power to the extent of nine millions three hundred and ten thousand nine hundred and six dollars and sixty-six cents, leaving a sum of five millions eighty-nine thousand and ninety- 50 three dollars and thirty-four cents which may be raised under such powers. And whereas, under section six of "The Great Western Railway Company's Financial Act, 1871, the company is declared to have further power of borrowing upon perpetual debenture stock the sum of three million four hundred and eighty-two thousand 55 and one hundred and seventy-four dollars and seventy-one cents,
