WHEAT-CONSULTATIONS WITH U.S. ON DISPOSAL OF SURPLUS

On the orders of the day:

Mr. K. H. More (Regina City): Mr. Speaker. I should like to direct a question to the Minister of Trade and Commerce. In view of the statement appearing in the Globe and Mail of March 28 suggesting fear of controversy between Canada and the United States of America over surplus wheat disposal, can the minister say whether plans have been made to hold talks between the United States of America and Canada to develop a variable system of multilateral world trade and urge a more determined policy regarding the disposal of surplus wheat?

Hon. Gordon Churchill (Minister of Trade and Commerce): Mr. Speaker, Canada and the United States have developed consultative machinery so that views and grievances may be discussed at the ministerial and the official levels. One practical result has been the discontinuance of United States barter deals for wheat in many commercial markets. Approximately six months ago the United States announced that the United Kingdom, Belgium, Luxembourg, The Netherlands. Germany and Switzerland have been deleted from their barter list for wheat, flour and feed grains. Although the United States barter program remains a potential threat to Canadian commercial exports, its actual impact on such exports has been considerably reduced in recent years. We are keeping a close watch on developments.
