Mr. Pepin: This matter is now in the hands of the Minister of Energy, Mines and Resources, but when these arrangements were made I was trying to implement intelligently a policy devised by the Conservatives back in 1960.

Mr. Hees: Does the minister realize that by his answer he is making Hon. Paul Martin look like a plain, blunt spoken man, and the essence of clarity?
