

*Inquiries of the Ministry*

**Hon. A. J. MacEachen (Minister of Manpower and Immigration):** Mr. Speaker, Mr. Rubin did spend a couple of days, or less than that, in Canada last week. He was admitted at Toronto airport. He attended three universities and the results were rather harmless. He did not make much of an impression.

**Mr. Diefenbaker:** I wasn't asking about the harmless results. I was trying to find out who slipped up, so that he got in through the immigration checkpoint?

**Mr. MacEachen:** Mr. Speaker, the admitting officer in Toronto admitted Mr. Rubin. I think if he had known the full facts he might not have admitted him, but in any event he did admit him.

**Mr. Diefenbaker:** Has this immigration officer, and have immigration officers in general, received word or advice from the minister's department that Rubin was persona non grata in Canada and should not be admitted?

**Mr. MacEachen:** Mr. Speaker, I think it was last October, and then in December we determined in the department that he should not be re-admitted into Canada, and this word was sent out to the officers. In this particular case at the Toronto airport, the particular officer did not recognize the man he was dealing with.

**Mr. Diefenbaker:** Under what name did he come in?

**Mr. Lincoln M. Alexander (Hamilton West):** Mr. Speaker, I wish to direct a supplementary question to the Minister of Manpower and Immigration. In view of the fact that the government has arrived at a conclusion with respect to a known agitator, Jerry Rubin, has it arrived at other conclusions with respect to the admission or non-admission of other known agitators who have been in Canada in the past year or so, and as a result of whose admission the whole country seems to be living in fear of what is going to happen, in terms of student riots and the like?

**Mr. MacEachen:** Mr. Speaker, the expression "known agitators" is not very helpful to the department in reaching a decision of this kind. The case of Rubin was clear cut. He had been in Canada last fall and had taken certain actions which we thought were not in accordance with the public order of the country. For that reason we did make a decision that his return to Canada would not be

desirable. He did come back and he made some speeches, but the speeches did not have that earth-shaking effect that they might have had.

**Mr. Andrew Brewin (Greenwood):** As a supplementary question, Mr. Speaker, would the minister discuss with the Chairman of the Parliamentary Committee on Manpower and Immigration the possibility of arranging shortly for a discussion of this matter, and the related matter of deserters and draft dodgers which has come up from time to time in the house and which is causing a great deal of confusion and unhappiness generally?

**Mr. MacEachen:** Yes, Mr. Speaker, I would be glad to discuss that matter with the committee chairman.

**Mr. Diefenbaker:** Mr. Speaker, in view of the fact that a decision was made to bar Rubin could the minister let us have the expurgatorious list covering the names of individuals who were in Canada last fall and who have since, as a result of a declaration by the department, been rendered inadmissible to Canada? Could he give us that list?

**Mr. MacEachen:** Mr. Speaker, I am not aware of any list of that kind.

**Mr. Diefenbaker:** Have you any other list?

**Mr. Speaker:** The hon. member for Wellington.

**Mr. MacEachen:** Mr. Speaker, we must deal with these cases on an individual basis. I have explained the circumstances surrounding Mr. Rubin's entrance into Canada.
