FISHERIES AND FORESTRY—TREATMENT OF SURPLUS EMPLOYEES—USE OF PUBLIC SERV-ICE COMMISSION REVIEW PROCEDURES

Mr. David Orlikow (Winnipeg North): Mr. Speaker, on February 20, in the absence of the Minister of Fisheries and Forestry (Mr. Davis), I directed a question to the Prime Minister.

The Parliamentary Secretary to the minister replied that he did not think this was necessary because the department felt it had established the most complete and competent review procedures possible and employees have the right to appeal decisions made with regard to lay-offs.
