An hon. Member: You mean 11 to 16.

Mr. Knowles (Winnipeg North Centre): I thank my hon. friends. Yes, I mean 11 to 16. These amendments have the effect of opening certain options which Senators were given when they were placed on a retirement-at-75 basis, and they contain one or two other benefits which are being offered to them. My feelings about these proposals are similar to those I expressed earlier today with regard to those which affect ourselves, except that I feel even more strongly about them.

This bill would re-open certain options to Senators, some of them having decided, it would seem, that they chose the wrong option previously. I think it is a little much to allow them to go into that again. I think of the dozens of letters I receive from railroaders and others on pensions who want certain options to be opened or re-opened, but who are told this cannot be done because it would be in violation of the terms of a contract.

This amendment of mine would, therefore, remove all those portions of the bill relating to what is being done for the Senators except for clause 28 which would require them to pay one-half of one per cent to help pay for the supplementary benefits which they, too, will receive. I hope the House will support motions 11 to 16 inclusive.

Mr. Deputy Speaker: The hon. member for Winnipeg North Centre (Mr. Knowles) moves:

That Bill C-194, to provide supplementary retirement benefits for certain persons in receipt of pensions payable out of the Consolidated Revenue Funds and to amend certain acts that provide for the payment of those pensions, be amended by deleting therefrom clause 22 of the said bill.

Those in favour of the motion will please say yea.

Some hon. Members: Yea.

Mr. Deputy Speaker: Those opposed will please say nay.

Some hon. Members: Nay.

Mr. Deputy Speaker: In my opinion the nays have it.
