Affairs. Did the minister announce in Vancouver recently, or over the weekend, a policy of government loans for the rehabilitation of existing housing stocks? If so, will he be introducing legislation to this effect in the House soon?

**Mr. Speaker:** Order, please. I suggest to the hon. member that the second part of the question, or only the second question, is in order and the minister will be allowed to reply to it. Possibly the hon. member will get information relating to the first part of his question in this way.

Hon. Ron Basford (Minister of State for Urban Affairs): Mr. Speaker, I did mention that we had an experimental program in Vancouver that was established by my predecessor in the Strathcona housing area. There was an experimental program of loans and grants to home owners to rehabilitate their homes. I said we were learning a great deal from that program.

**Mr. Speaker:** Order, please. That is the kind of question and answer about which there are procedural difficulties. The hon. member may ask his question directly. When he asks it as the hon. member did and obtains the sort of reply the minister gave, then the debate is over what was said outside the House. In that respect that type of question and answer is irregular.

**Mr. Brewin:** Mr. Speaker, I hope I am phrasing my supplementary question in the proper manner. Is it proposed to introduce legislation in the House to expand and extend the provision for loans for the rehabilitation of existing housing?

**Mr. Basford:** Mr. Speaker, I think that legislation will be introduced in due course, as predicted in the Speech from the Throne, and when introduced it will reveal what it deals with.
