DORCHESTER—ALLEGATION SPECIAL GUARDS FOR AMBROSE AND HUTCHISON BEING PAID BY PROVINCE—GOVERNMENT POSITION

Mr. Paul Dick (Lanark-Renfrew-Carleton): A final supplementary question, Mr. Speaker. Would the Solicitor General confirm that there are seven guards who have been taken off their regular duties to secure the area Ambrose and Hutchison are in, that these are being paid by the province under a special arrangement, but that since they have been taken from the regular contingent, the regular contingent is now light these seven guards; and that as of July 1 two posts were cut by the penitentiary service and there are seven posts short this weekend, a crucial weekend?

Hon. Warren Allmand (Solicitor General): Mr. Speaker, I do not have those details. However, I am told that everything is under control at Dorchester penitentiary. The hon. member is quite correct in stating that Ambrose and Hutchison were being guarded by provincial employees. Under ordinary circumstances inmates on death row are in provincial prisons. Because of the special security problems in New Brunswick, and the fact that they had no institution which they felt was suitable for these inmates, they made a special arrangement with us to keep these two fellows at Dorchester pending the outcome of their appeals.

BELLEDUNE FERTILIZER CORPORATION—THREATENED LAY-OFF OF EMPLOYEES—GOVERNMENT ACTION

Mr. Maurice Harquail (Restigouche): Mr. Speaker, I have a question for the Acting Prime Minister. In view of plans by the Noranda group to close its subsidiary company, Belledune Fertilizer Corporation, shortly, I wonder whether the Acting Prime Minister would take up the matter with the Minister of Industry, Trade and Commerce as well as the Secretary of State for External Affairs and arrange discussions to see whether some solution might be found to this problem to avoid laying off some 200 people in that area already bothered by high unemployment?

Hon. Mitchell Sharp (Acting Prime Minister): I am prepared to do so, Mr. Speaker.

THE CANADIAN ECONOMY

GOVERNMENT MEASURES TO DEAL WITH POST-CONTROL PERIOD

Mr. Andy Hogan (Cape Breton-East Richmond): Mr. Speaker, in the absence of the Prime Minister I will direct my question to the Acting Prime Minister. The chairman of the Economic Council of Canada was quoted recently as saying that he supports the Canadian Labour Congress in the belief that, and I quote, "a system of national, social and economic planning is indispensable" for Canada. Does the Acting Prime Minister agree with Dr. Raynauld and, if so, can we soon expect position papers by the government

on this part of the government's policy when the present ill-conceived controls are lifted?

Hon. Mitchell Sharp (Acting Prime Minister): Mr. Speaker, the government has been giving urgent consideration to the policies that would be appropriate following the end of the anti-inflation program. It has been having some discussions with various parties, including the leading representatives of the trade union movement, with the Economic Council and with a number of other agencies. However, the problem is of such complexity that I would not think it would be possible to put these plans before the House before it adjourns for the summer break. It would be our hope, however, that in the new speech from the Throne some indication could be given of the government's approach.
