CROWSNEST PASS RATE—CABINET POLICY

Mr. Stan J. Hovdebo (Prince Albert): Madam Speaker, my question is for the Right Hon. Prime Minister. It concerns the question put by the hon. member for Provencher, and it is really supplementary to it. With regard to the speech given on Wednesday by the minister responsible for the Wheat Board in which he unequivocally supported the continuation of the

Crowsnest freight rate, it is clear that the minister was speaking for cabinet when he made that policy statement that there will be no changes in the Crow rate?

Right Hon. P. E. Trudeau (Prime Minister): Madam Speaker, I believe that that is the answer I gave a moment ago. At present there is no decision and no intention in cabinet to change the Crow rate. I understand that even the western premiers cannot agree on whether or not it should be changed. Apparently the province of Saskatchewan is opposed to any change. The other two prairie provinces want change.

HALL REPORT RECOMMENDATIONS

Mr. Stan J. Hovdebo (Prince Albert): Madam Speaker, I like that statement except for "the present time" part of it. Regardless of the statements being made by the various ministers who are indulging in an attempt to establish public opinion across the west, there is a great deal of consensus among farmers that the Crowsnest freight rate should stay as is.

My supplementary question is for the Minister of Transport, but perhaps his parliamentary secretary, the hon. member for St. Boniface, could answer it. In its deliberations on the Crowsnest freight rate is the Department of Transport taking a good look at the recommendations in the report of Mr. Justice Emmett Hall on grain handling and transportation, and considering extending the Crow benefits to other products to alleviate some of the concerns of the people who are bothered by the level of Crow rates?

Mr. Robert Bockstael (Parliamentary Secretary to Minister of Transport): Madam Speaker, the Ministry of Transport has been receiving delegations from various commodity representatives and groups interested in freight rates in the west. Their representations are being taken into consideration. At some future date the minister will be making recommendations to cabinet.
