ANNOUNCED CHANGE IN NAME OF RIDEAU CENTRE

Mr. Jean-Robert Gauthier (Ottawa-Vanier): Madam Speaker, I seek unanimous consent under the provisions of Standing Order 43. After ten years of co-operative planning of downtown Ottawa between the private sector and all levels of Government in a joint development and construction project known as the Rideau Centre, the T. Eaton Company Limited, one of the participants, announced its intention to change the name of Rideau Centre to Rideau Eaton Centre.

Considering that the name Rideau is an important part of the cultural heritage of the National Capital; considering that, while the T. Eaton Company Limited is a welcome backer of the project, many other private companies and all levels of Government have also financed a large share of the Rideau Centre area; considering that all local officials consulted, namely, the City of Ottawa, the Regional Municipality of Ottawa-Carleton, and merchants and citizens associations have expressed their opposition to the proposed name change, I move, seconded by the Hon. Member for Nepean-Carleton (Mr. Baker):

That this House ask T. Eaton Company Limited to reconsider its decision and maintain the name Rideau Centre, Centre-Rideau.
