Hon. Erik Nielsen (Deputy Prime Minister and President of the Privy Council): Mr. Speaker, speaking on behalf of the Prime Minister, of this Government, and this Party, I can assure the Hon. Member that we are deeply committed to the Official Languages Act which we supported when it was introduced by the previous Government almost six years ago.

With respect to the specific question, which falls within the jurisdiction of the Minister of Justice who is absent today, I shall take notice of the Hon. Member's question and ask the Minister to be in touch with the Hon. Member.

LONG-TERM UNEMPLOYED

Mr. Ian Deans (Hamilton Mountain): My question is for the Minister of Employment and Immigration. She knows that we have added 50,000 to the rolls of the unemployed in the last month alone, and that we have 244,000 people who have been unemployed for between six months and a year already. She knows her program will provide only 70,000 jobs during this winter. There is a tremendous short-fall. Will the Minister bring forward new programs now to try to meet at least the requirements of those who seem to be long-term unemployed?

Hon. Flora MacDonald (Minister of Employment and Immigration): Mr. Speaker, as I have said many times in this House, \$1 billion has been dedicated by this Government to new job opportunities and to developing human resources. That \$1 billion will be spent to the benefit of Canadians in this field. It will not be frittered away on partisan boon-doggling as it has in the past. I would say to the Hon. Member that that \$1 billion will be allocated in a way that will bring real solutions to the problems of unemployment.

PLIGHT OF UNEMPLOYMENT INSURANCE EXHAUSTEES

Mr. Ian Deans (Hamilton Mountain): I have a supplementary question for the Minister of Employment and Immigration. Doesn't the Minister recognize that the 244,000 people who have been unemployed for over six months have lost benefits, are not able to meet their commitments, and cannot wait for the Government to introduce its programs to spend the billion dollars? Will she move now to provide them either with an income or with a job opportunity?

Hon. Flora MacDonald (Minister of Employment and Immigration): Mr. Speaker, it is because we recognize that the problems of the unemployed have not been solved by the kinds of past programs he is advocating that we will take the time necessary, and without any excuses whatsoever, to work out the best possible programs that will address the needs of these people who are in such desperate need.

Mr. Deans: When?

Miss MacDonald: I can tell the Hon. Member that those consultations are going on right now. They are going on with labour unions, with business, and with provincial Governments. When we present those programs, it will be with the undertaking that they do the job.
