SALE OF ASBESTOS TO THAILAND

Question No. 313-Ms. McDonald:

To the knowledge of the Government, is Canadian asbestos sold in Thailand and, if so, is information provided to users about the known or potential health effects of asbestos and, if so, what is it?

Right Hon. Joe Clark (Secretary of State for External Affairs): In 1987, Canada shipped asbestos cloth and fibres to Thailand valued at \$18.8 million. In Thailand, the major end uses of asbestos fibres are asbestos cement sheet/pipe and roofing (80 per cent), brakes and clutches (15 per cent), and vinyl floor tiles (5 per cent). Bags of asbestos fibres entering Thailand are stamped with warning labels in six languages. In accordance with Thai regulations, pallets loaded with bags of asbestos fibres entering Thailand are labelled in Thai with cautionary statements, a practice which started in 1985. Thai regulatory authorities at the Ministry of Industry are well aware of the potential health effects of asbestos. Under their regulations, only blue asbestos or crocidolite is not permitted entry into Thailand. Import permits are required in Thailand to import other types of asbestos fibres which are issued by the Hazardous Substances Division of the Thai Ministry of Industry. The Canadian Asbestos Institute has conducted seminars in Thailand in August, 1985, and in February, 1988, on the health, safety and handling of asbestos for the Thai regulating agencies and users.
