VIA RAIL

Mr. Peter Milliken (Kingston and the Islands): Mr. Speaker, the Draconian cuts announced yesterday by the Minister of Transport constitute yet another arrogant

and abusive Tory tactic to destroy one of our national institutions. Why else would the Minister cut early morning train service from Canada's fifth busiest station, Kingston, to Canada's largest city, Toronto? This is a service that carried over 76,000 passengers last year according to the minister's own figures. Why else cut this train that serves Napanee, Belleville, Trenton, Port Hope, Cobourg and Oshawa? Why else cut redcaps who help the elderly, the infirm and the handicapped?
