9,000 Canadian businesses have declared bankruptcy. More than 50,000 individuals have suffered the same fate. This is the fate of a country led by a government which is bankrupt, ethically and intellectually.

I advise honourable senators opposite, and particularly Senator Poitras that you will get an opportunity later today under Inquiry No. 16 to show cause why you believed these predictions were true.

Hon. Jean-Marie Poitras: Honourable senators, now is the time I think to deal with the predictions made last year in this place by our honourable colleagues opposite.

You probably all remember, honourable senators, that we were going to have a huge inflation—several points, two and a half points at the very least and that was a conservative estimate. You also remember how the honourable senators opposite helped prepare the public to absorb the choc of this legislation by delaying passage of the bill, up to the very last minute.

It is generally acknowledged as obvious now that the delays caused in this place are partly responsible for the hardship being suffered today.

You will remember as well of years past when interest rates were at 22 per cent. Under what government, Senator Olson, was it that we had those 22 per cent interest rates?

Now, we are paying for those mistakes, while interest rates are at their lowest level in nearly 20 years. That is what baffles us.

Finally, I hope that we will hear a statement to the effect that the leader of the Liberal opposition, is committed to abolishing this tax in its entirety if and when he or his successor assumes power. This way we would have a pretty good idea of what to expect. Thank you, honourable senators.

Hon. Roméo LeBlanc (Beauséjour): Well, you believe in Santa Claus!
