Mr. Boulanger-On Monday next-The following proposed Resolution:-That, in the opinion of this House, in order to conform with the constitution, to safeguard the autonomy of the provinces and the betterment of their finances, the Federal Government should cease making financial contributions towards the execution of projects which are entirely within the jurisdiction of said provinces.

Mr. Pelletier-On Monday next-The following proposed Resolution: That, in the opinion of this House, the Government should consider the expediency of amending section one of "An Act to amend the Soldiers' Settlement Act," being chapter ten of the Statutes of 1936, as follows:-

That the words reading "up to and including the thirty-first day of March, 1938" which appear in that section, should be changed to read as

follows: "Up to and including the thirty-first day of March, 1941."

Mr. Martin-On Monday next-The following proposed Resolution:-Whereas the creation by Parliament of a Board of Grain Commissioners indicates governmental interest in the movement of grain throughout Canada for both domestic and export sale;

And whereas, from time to time Parliament has enacted measures dealing with the grain trade, providing for inspection and other necessary services;

And whereas, in the South-western peninsula of the Province of Ontario the bulk of the production of corn in Canada is to be found, this production being an important factor in the income of the farming community and the economy of the area generally;

And whereas, the facilities for the marketing of the said production are

inadequate,

Therefore be it Resolved,—That, in the opinion of this House, the Government

- (a) should consider the necessity for improved marketing facilities;
- (b) should consider the need for providing adequate storage, drying, government grading and inspection facilities in order that the quality of the corn be improved and its production increased.
- Mr. Neill-On Monday next—the following proposed Resolution:—That, in the opinion of this House, the Government should investigate the desirability of establishing some form of naval reserve on the Atlantic and Pacific coasts whereby in the slack winter season suitable fishermen could be trained to become a first class naval seamen reserve on somewhat similar lines to that established in Great Britain.

The Prime Minister—On Monday next—That Standing Order 56 be amended by adding the following as Section (5):

(5) At the commencement of every session, or from time to time as necessity may arise, the House may appoint a Deputy Chairman of Committees who shall, whenever the Chairman of Committees is absent, be entitled to exercise all the powers vested in the Chairman of Committees including his powers as Deputy Speaker during Mr. Speaker's unavoidable absence.

The Minister of Pensions and National Health-On Monday next-In COMMITTEE OF THE WHOLE—The following Resolution:-

Resolved, That it is expedient to amend The Canada Shipping Act, 1934, (Part V, Sick Mariners and Marine Hospitals) in respect to the levy and collection, and in certain cases the remission, of ship dues.
