every minute to buy such stocks, while they sell them and pocket the cash. You may well pause and ask in wonder how such a thing could possibly have happened in the civilized and enlightened City of New York.

The public service law above quoted has stopped all such "high financing." A similar law here would not allow a single dollar of watered stock to enter the capitalization of our public service corporations.

If Sir James Whitney wishes to see how efficacious this New York law is—and it is not yet two years old—we respectfully suggest to him that he request the secretary of the public service commission at Albany to send him the printed rulings and orders of the commission on the several applications that have already been made in regard to issues of additional stocks, bonds, etc., of public franchise corporations in New York State. These rulings are most illuminating.

MUM ON THE GREAT ISSUE. The question of supreme importance to the people of Canada to-day is that of the capitalization of public franchise corporations. It is almost idle to talk of regulating rates of railways if we do not regulate and oversee the capitalization on which rates must be collected.

The question has been up in parliament twice, yet the newspapers—the party newspapers—are nearly all mum. What does The Globe think of the order-in-council authorizing the Canadian Pacific to divide \$20,000,000 among its shareholders as a "melon" bonus?

What does The Mail, The News, The Star think about this matter? The Montreal Star, also? And The Spectator of Hamilton and The Citizen of Ottawa?

As to whether the agreement constituted a co-partnership or co-ownership, I am of opinion that it was a co-partnership agreement.
