was simply sat upon. The wheels of the machine were started and it had to roll on.

No election had been announced when the meeting was held and it is not known whether there will soon be an election or not.

It was well to reorganize the old party and again place it in working order. It was well to avoid the mistake of 1891, when Mr. Mitchell was nominated without even going through the formality of calling a meeting of the party for the purpose, but was not right to call a meeting for a Monday afternoon—of all other times in the week—when liberals from the remote up-river parishes could not, save at great inconvenience, attend and pre-arranged nomination through writ or writ proceeding the rule of the Association on the subject.

There never was a time in the history of Northumberland when the people generally were so pathetic as they are in the face of a pending Dominion election.

There are, doubtless, numbers on both sides of politics who are very much in earnest, in supporting the candidates of Messrs Adams and Mitchell, respectively, but the vast majority of the voters of the County have been misled, for some time, that Mr. Adams' notwithstanding, his many excellent qualities, has failed to meet the reasonable expectations of those who have supported him since 1891.

In many cases, it is probable that almost any other man would have similarly failed, but in many others, he has displayed lack of aptitude, or of judgment, faith of industry and an almost total disregard of duty of placing himself on equal footing with the people of the County—not showing himself to be interested in them and their concerns, or personally seeking to find out their wishes in regard to local public matters within his province as a member of parliament—thus alienating their interest in his personal regard for him. It is true that for a month or two past he has shown a disposition somewhat different from this, and extended the circle of his visits and conferences in the County, but it is also true that there is an election not far off, so the people will judge for themselves the real motive for this sudden desire to find out their wishes in regard to local public matters within his province as a member of parliament.

It is, of course, of no practical use at this time to say that in view of the comparative absence of party feeling in Northumberland, there is good reason to believe that Mr. Adams had the opportunity to make himself almost invisible in the County, but it is also true that he was not up four years ago by men of all shades of politics, who were tired of Mr. Mitchell and his absenteeism. They hoped that Mr. Adams, being with them and of them, would be always within reach and ready to respond to their requests. Had their expectations been realized, he would not have retained the support of those who voted for him in 1891, but won that of many who did not do so. To his own neglect in this matter is due the fact that he is not in the field as a candidate for any of the seats in the County, but the applications received were so numerous that this body of distribution all the available February, and all later applicants could not be considered.

The Young Man and the Church.

No little heartburning has been provoked by the recent frank discussion of the reasons why young men do not go to church, and many young men have been urged to do so.

Winnipeg again?

Erasmus Wiman, who was so important a factor in the Dominion election of 1891 and has been for a year or more a fugitive in New York, will probably "bob up" again in the next election, as the judgment of the convicting court has been reversed by the Supreme Court of the State. A New York dispatch says: "Erasmus Wiman is now so intent and purpose a free man. The people may expect to see him in the next election, and he will make a new man. He may drop the whole business, but if he should appear to the Court of Appeals and the latter court should support the

reversal of judgment, that would end the case forever. The case was long kept by one of the District Attorneys. He decided to take a new trial, the whole business being done over again with the chance of, as in all our trials, the prosecution not doing so well in the second trial as in the first. It is the opinion among lawyers, and they said so further, that the agreement of Judge Van Brunt, a general lawyer, would be assisted by the higher court should an appeal be taken. Consequently it was generally believed that the people would get the case over where it is.

Wiman had been sentenced to five years and six months in State prison for forging a \$200 check. Judge Van Brunt held that Wiman was a member of the firm and that the withdrawal of funds from the assets of the firm for his own purpose did not constitute a criminal offense. He said it was abundantly shown that Wiman was aware of the overdraft.

Apart altogether from the merits of the charges against Wiman, it is to be hoped that his old associates in Canada in politics will not renew their relationships with him. These ought to be placed among the honest public men for such as Messrs Adams, Mercier, Wiman, Owen Murphy, Pacand and others of their class.

Liverpool Wood Market.

The returns of consumption and stocks of wood goods in Liverpool on last instant are not encouraging. Only 2,333 standards of New Brunswick and Nova Scotia spruce and pine deals were consumed in February 1895 as against 3,531 standards in 1894, while the stock on hand 28th February last was 18,001 standards, against only 11,913 standards on the corresponding date last year.

The death of Worth, the great Parisian dressmaker, is announced. The New York Herald says: "Much interest and much regret will be excited by the announcement that Mr. Worth, that monarch of the fashioning world, that king of couturiers, is dead. Nature's waywardness was never better illustrated than in her choosing a bluff Englishman and sending him forth from his native Lincolnshire to beat the French Czar on a ground that previously had been considered peculiarly their own.
