## PART VIII NATIONAL LIBRARY

**73.** Paragraph 9(2) (c) of the *National Library Act* is repealed and the following substituted therefor:

“(c) three other persons, one each representing and nominated by the Canada Council, the Social Sciences and Humanities Research Council and the Association of Universities and Colleges of Canada; and”

## PART IX TRANSITIONAL AND COMMENCEMENT

### *Transitional*

Continuation in office of chairman of Science Council of Canada

**74.** (1) Notwithstanding section 44, a person who, immediately before the coming into force of that section, held the office of chairman or vice-chairman of the Science Council of Canada shall be deemed to have been appointed immediately after the coming into force of that section, to hold that office for the remainder of the term for which he had been appointed before the coming into force of that section.

Continuation in office of President of National Research Council

(2) Notwithstanding section 53, the person who, immediately before the coming into force of that section, held the office of President of the National Research Council shall be deemed to have been appointed to hold that office immediately after the coming into force of that section, for the remainder of such term as the Governor in Council had prescribed at the time that person was appointed to that office before the coming into force of that section.
