RENEWAL OF U.K.-CANADA TAX AGREEMENT

Mr. Eric A. Winkler (Grey-Bruce): Mr. Speaker, I have a question for the Minister of Finance. According to reports the current Anglo-Canadian tax agreement will lapse on December 31, 1964. Will the minister say what efforts he is making to renew this valuable agreement, or inform the house what course the government intends to follow?

Hon. Walter L. Gordon (Minister of Finance): Mr. Speaker, meetings of officials of the United Kingdom and Canada were held in Ottawa starting on September 28 to discuss a revised agreement. At these meetings a draft for a revised agreement was prepared, and in accordance with usual practice this draft was then placed before the two governments for their consideration. As I mentioned yesterday, I think it was, there has been an election in the United Kingdom in the interim which has no doubt slowed up this matter to some extent.

I should like to take this opportunity, Mr. Speaker, to say it is incorrect to suggest that double taxation will suddenly exist or that business firms will be hurt if the new agreement is not ready to be put into operation on January 1, 1965. Both Canada and the United Kingdom have measures in their income tax legislation to prevent double taxation by allowing credits for taxes imposed by other countries, and these provisions will continue in operation even if there is no income tax agreement between the two countries in question.

Mr. Winkler: A supplementary question, Mr. Speaker. Will the minister say whether it is his intention to press for the renewal of the agreement?
