Last night the Minister of Finance (Mr. Sharp) referred to some incentives. He said the following, as recorded on page 2733 of Hansard:

while a remission of the sales tax on building materials is a desirable reform, it is one that is not nearly as important as many others, or many other more important steps that may be taken.

I suggest that if the Minister of Finance believes the removal of the sales tax on building materials is not the most important step that should be taken in order to reduce the cost of housing in this country, then it is his duty to tell us what other measures should be undertaken in order to alleviate the problem. The Minister of Finance, realizing the mess in which we now find ourselves, told us in general terms that there are many other remedies, but he did not specify what they were. He contented himself with saying that we have problems which are going to be resolved but they are going to be resolved at the cost of depriving the majority of Canadians of the right to own their own home. This is the suggestion which he has made. He suggested that time alone will cure this ill. I suggest this is a poor approach to the problem.

The hon. member for Winnipeg North (Mr. Orlikow) today suggested the removal of the sales tax on building materials used in house construction, but on the other hand said the sales tax should be retained for commercial projects. I do not accept that approach. If we are to remove the sales tax let us remove it completely. Let those with the ability to develop, develop. I do not wish to see the poor remain poor. Let us improve their lot and at the same time allow others who have the incentive to produce retain that incentive and go on producing.

Earlier this year many big developers right across the country postponed construction projects, expecting that interest rates would drop. Now, major construction across the country will drop off. Who will suffer the consequences? The workers in the construction industry will suffer. Earlier in the year money was available at 73 per cent and 8 per cent for major construction. That money will now cost 83 per cent to 9 per cent.
