LABOUR RELATIONS

RAILWAY STRIKE—REPORTED STATEMENTS RESPECTING RETROACTIVE PAYMENTS

On the orders of the day:

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Mr. Speaker, in view of the fact that the interviews carried by the C.B.C. last evening by Mr. Gordon, president of the C.N.R. and Mr. Sinclair, president of the C.P.R, were to the effect that no provision had been made under either the legislation now before the house or the legislation to come for the payment of extra amounts in so far as they are retroactive, is the Prime Minister in a position to say whether the statements were correct?

Will he tell the house at the same time whether these recommendations or similar ones were made to him by these two gentlemen and what is the reaction of the government thereto?

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, in my view there was nothing said on the program in question which interfered in any way with the desirability and the possibility of implementing the legislation now before the house, if the house adopts that legislation.

The railway representatives, when they called on me yesterday, did indicate they might have some difficulty in carrying out this legislation because of revenue considerations. They outlined their position to me, Mr. Speaker, and I said I would look into it.

Mr. Thomas M. Bell (Saint John-Albert): Mr. Speaker, I have a question for the Prime Minister. Further to Mr. Sinclair's remarks wherein he stated that the second bill before the house does not provide any extra money for the railways that they do not already possess, does the Prime Minister wish to revise his opening remarks about the relationship between the two bills, and state whether he still intends to proceed immediately with the second bill?

Mr. Pearson: No, Mr. Speaker, I do not wish to revise my remarks. I suggest to Mr. Sinclair that he read the bill a little more carefully.

Mr. Starr: That applies to Mr. Gordon, too.
