connection, has the government received any indication from the British prime minister that Canadian interests might be jettisoned if such a course would facilitate the entry of Britain into the common market?

Hon. Robert Winters (Minister of Trade and Commerce): Mr. Speaker, perhaps I could be permitted to answer that question. Liaison committees have been set up in accordance with the agreement reached at the ministerial conference, and last week or the week before members of the Department of Trade and Commerce, supported by other departmental people on the site in London, did have a conference with their opposite numbers in London at which there was no mention of jettisoning.

POSSIBLE MODIFICATION OF ANNOUNCED POLICY

Hon. J. J. Greene (Minister of Agriculture): Mr. Speaker, as the hon. member knows, we are appointing a task force to review long term goals and objectives in agriculture, and we hope to announce very shortly the appointment of the personnel of that task force which will work in close conjunction with the most for farmers since he has assumed his

government. This will not be a commission that conducts its own deliberations and then reports in a year or two. If any of their recommendations require legislation, course it will be introduced and brought forward in the normal way. Apart from that, the government will continue to review the needs of the agricultural community and to bring forth any legislation or other direction which is needed to keep Canadian agriculture in the forefront.
