**NATIONAL SECURITY****WAR MEASURES ACT—DYNAMITE, ARMS AND AMMUNITION RECOVERED**

**Hon. John N. Turner (Minister of Justice):** I thank the hon. member for Halifax-East Hants.

**Mr. McCleave:** Just don't forget it.

**Mr. Turner (Ottawa-Carleton):** This is an example of the co-operation of Parliament, Mr. Speaker. Earlier in the afternoon the hon. member for Nanaimo-Cowichan-The Islands asked about seizures of dynamite. From a public statement made yesterday by Inspector Melançon of the Quebec Provincial Police it is my information that the number of weapons retrieved in the anti-terrorist raids since mid-October included a total of 116 offensive weapons, 2,976 rounds of ammunition and 2,609 sticks of dynamite. Inspector Melançon said that more than 1,800 sticks of dynamite remained unaccounted for out of the 4,500 stolen in the last several months.

**AVAILABILITY OF WEAPONS—PASSING OF ORDER IN COUNCIL**

**Mr. Eldon M. Woolliams (Calgary North):** Mr. Speaker, when the minister is dealing with weapons and the amount of dynamite stolen, I wonder if he would answer my question with respect to restricted and prohibited weapons and advise whether there was a prior Order in Council passed with regard to section 82(e) of the Criminal Code?

**Hon. John N. Turner (Minister of Justice):** Mr. Speaker, I want to be able to give the hon. member a full answer which includes not only an appreciation of the law but an appreciation of the facts and I will combine those when I give the answer.

**Mr. Baldwin:** If your law is no better than your facts you have a long way to go.
