## ESTABLISHMENT OF SEPARATE MINISTRY

Mr. Réal Caouette (Témiscamingue): Mr. Speaker, since the Prime Minister and the Secretary of State for External Affairs are absent, I direct my question to the Acting Prime Minister.

Hon. Robert K. Andras (Acting Minister of Indian Affairs and Northern Development): Mr. Speaker, as acting minister in the absence of the Minister of Indian Affairs and Northern Development I can assure the hon. member that the recommendations made to the Prime Minister and the cabinet yesterday were very respectfully received. They were very interesting and very constructive. The government is going to address itself to the examination of the options suggested by the Indian leaders, including that kind of recommendation, but they are so wide-ranging that some time is going to be required, as the Indian leaders fully understand, to examine all the suggestions before any decision is made.
