Mr. Trudecu: Is this a question in relation to general principle or is it in relation to James Bay, airports, or what? I am not certain.

Mr. Stanfield: It relates specifically to this situation.

Mr. Speaker: Order, please. The Leader of the Opposition.

Mr. Stanfield: I apologize to other hon. members waiting to ask questions but I should like to point out that I asked the Prime Minister a perfectly serious question and I do not intend to be put down by the Prime Minister or by the hon. member for St. Boniface. I want to ask the Prime Minister whether he considers he is discharging his responsibilities to the Indians by simply having the government conduct an environmental study while at the same time allowing the project to proceed before the environmental study is finished.

Some hon. Members: Hear, hear!

Mr. Trudeau: The answer is no, Mr. Speaker.

Mr. Stanfield: What are you doing, then?

Mr. Trudecu: We do not discharge our duties in that way. The environmental studies have been going on and, as the Minister of the Environment said, there has been a first report and there will be a further report. In the meantime, the Indians are before the courts of Quebec taking action to stop the project proceeding. I said a moment ago that this was done with federal support, with federal funds.

Mr. Nielsen: You are not discharging your responsibilities to the Indians.

Mr. Trudecu: I should like to know how the opposition would propose to deal with this particular responsibility in better ways than we have.

Mr. Speaker: Order, please.

WAR VETERANS ALLOWANCES—REQUEST THAT ACT OR REGULATIONS BE AMENDED TO ENSURE THAT PRO-MISED OLD AGE PENSION INCREASE NOT DEDUCTED

Mr. Knowles (Winnipeg North Centre): Can the minister say when it will be announced?

Mr. MacDonald (Cardigan): That is a matter of government policy, Sir, but it will be announced before very long.

WATER LEVELS IN GREAT LAKES—SUGGESTED CONTROL BY CREATING RESERVOIR IN LAKE NIPIGON AREA

Mr. B. Keith Penner (Thunder Bay): Mr. Speaker, my question is for the Minister of the Environment. I should like to ask him whether he is aware of the scheme which has been proposed by Mr. Lorne Henderson, a member of the Ontario Legislature and chairman of the Ontario Select Committee on Land Drainage, in which he suggests that 14,000 square miles in the Lake Nipigon area of northwestern Ontario be flooded, thereby creating a huge reservoir in an effort to control the water levels in the Great Lakes?

Hon. Jack Davis (Minister of the Environment): Mr. Speaker, we will take a careful look at it. A reservoir in that area could not affect the lower lake levels for at least a year, and possibly two.
